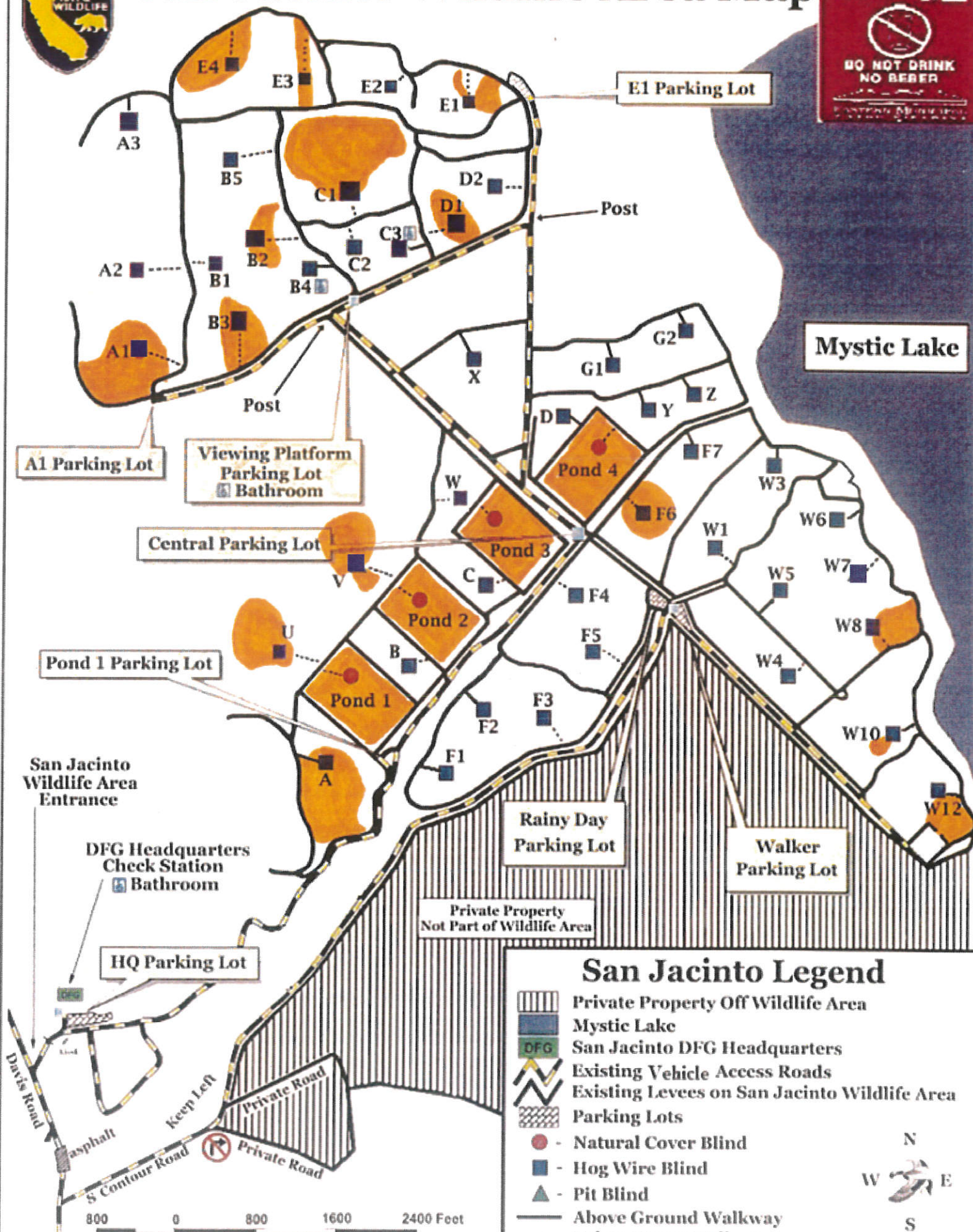

1. Handicap reservations will be assigned to designated handicap sites **ONLY!**
2. You **MUST** hunt from your designated hunt site or you will be removed.
3. * **Mechanical Spinning wing Decoys are prohibited until December 1st ***
4. Bag Limit: Please refer to the CDFW Regulations

DUCK LIMIT: 7 POSSESSION LIMIT: Triple the daily bag limit.

7 --- Mallard (No more than 2 females)

1 --- Pintail (Either sex)

2 --- Canvasback (Either sex)

2 --- Redhead (Either sex)

2 --- Scaup (Either sex, after November 7th)

25 - Coots (Either sex)

23 - Geese (20 white geese, 3 dark geese)

2 --- Black Brant (Either sex, after November 9th – 15th)

5. Reservation card holders first, then sweat line drawing next.
6. Non-reservation holders will complete a sweat line drawing list and the drawing will be pulled IMMEDIATELY at 3:30 AM.
7. Normal refill list will continue after all blinds are filled. You must be present to sign up for the refill list.
8. Each blind is allowed 4 people in any combination.
9. No refills or walk-ons after 2:00 PM.
10. **NO lead shot!** Steel, Bismuth, or Tungsten ammo only.
11. 25 shot shell limit while in the field.
12. PICK UP ALL TRASH AND SPENT SHELLS. Please keep San Jacinto Wildlife Area clean.
13. All hunters **MUST** check in and out at the Check Station.
14. Always Keep Entry Permit Card in possession while in the field.
15. **ALL HUNTERS MUST CHECK IN ALL BIRDS TAKEN.**
 - Please bring all birds to the check station to give CDFW employees a personal view.
 - Failure to do so will result in a loss of hunting privileges.
16. **Please work together!**
 - No jump shooting.
 - Keep shots within a reasonable distance. (No "sky busting" or "sky scraping")
 - No standing and shooting from the levees.
17. SJWA is a Type A Wildlife Area and all hunters are required to have a Type A Wildlife Area Pass.
18. **NO ALCOHOL OR CONTROLLED SUBSTANCES PERMITTED.**
19. All cigarettes must be extinguished and placed in the trash can or other appropriate containers.
20. **ALL HUNTERS ARE EXPECTED TO HAVE READ THE CALIFORNIA REGULATION BOOKLET.**
